The Higher Diploma in Accounting is designed to provide students with professional and broad-based education in accounting. It consists of 2 years of study. The first year of study follows a common core curriculum, in which all students will have to enroll in the generic and core business courses. These modules provide students with training in languages and general education as well as knowledge of the foundation of business. Business courses such as financial accounting, auditing, taxation and economics will be included. This arrangement will give students the opportunity to explore the areas they are interested in. In the second year, students will specialise in one of the following themes:

- Accounting and Banking
- Accounting and Financial Planning
- Accounting Studies

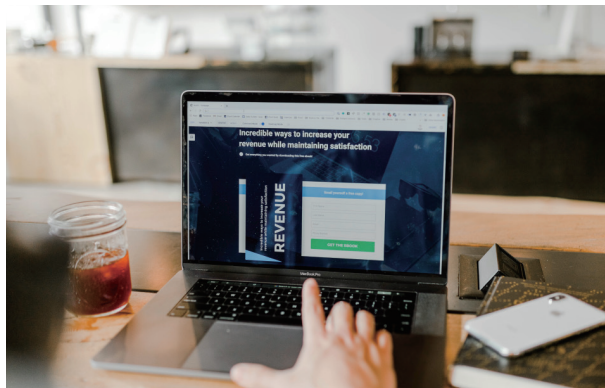

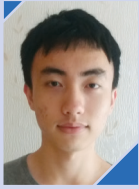

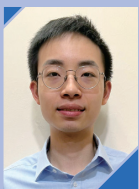

# MINIMUM ENTRY REQUIREMENTS

## 最低入學資格

- Obtain Level 2 or above in 5 subjects\*<sup>§</sup> including English Language and Chinese Language<sup>#</sup> in the HKDSE Examination; OR 香港中學文憑考試其中五科\*<sup>§</sup>(包括英國語文及中國語文<sup>#</sup>)考獲第二級或以上成績；或
- Hold a recognised Diploma in Foundation Studies Programme; OR 完成基礎專上教育文憑課程；或
- Hold a Diploma of Applied Education / Diploma Yi Jin; OR 完成應用教育文憑 / 毅進文憑課程；或
- Equivalent qualifications will be considered by the College. 書院亦會考慮同等學歷之申請。

Applicants who do not meet the entry requirements of the 2-year Higher Diploma programme should apply for admission to the Diploma in Foundation Studies (DFS).

### Recognition of Prior Learning (RPL)
